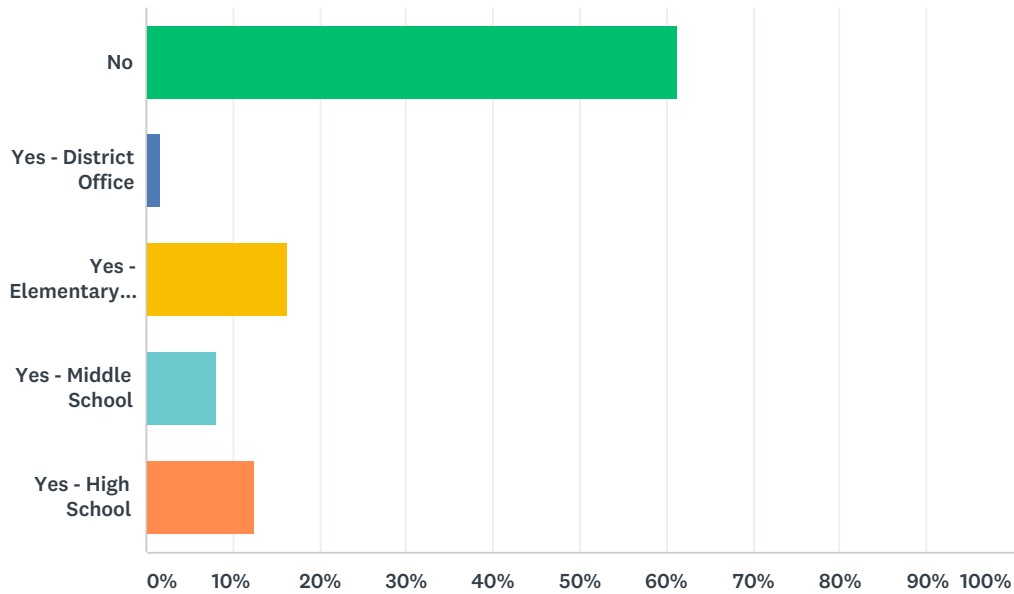


Q1 Are you an employee of the Northwestern Local School District? If you answer yes and work in multiple buildings please select the building where you spend the majority of your work day.

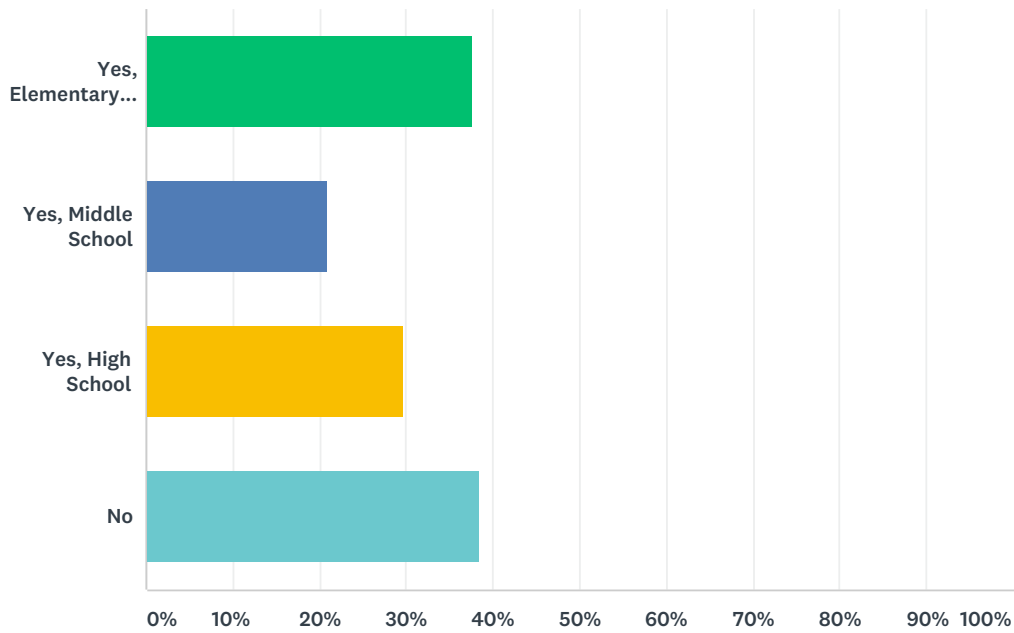

Q2 Do you have children enrolled in Northwestern schools? If so, which building(s)? Please check all that apply.

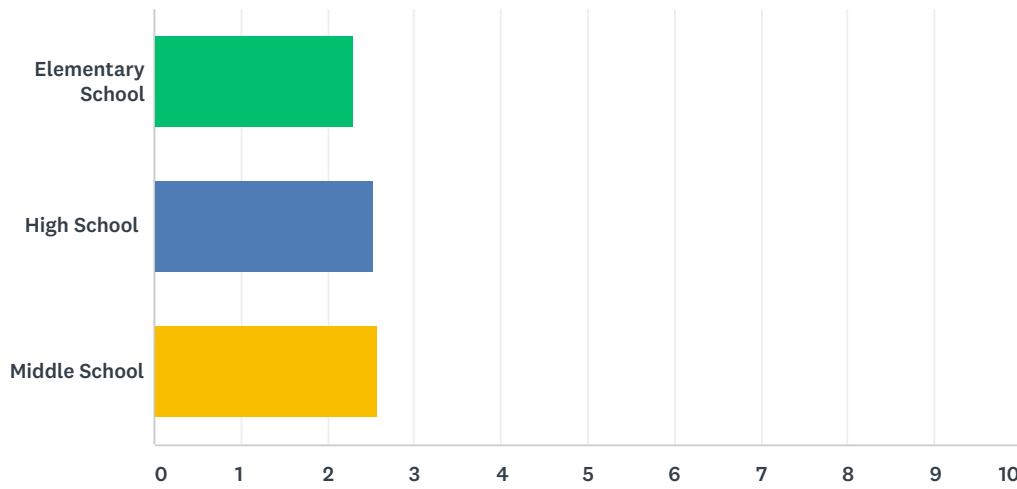

Q3 Do you believe appropriate security measures are being implemented to ensure student safety at Northwestern Local Schools?

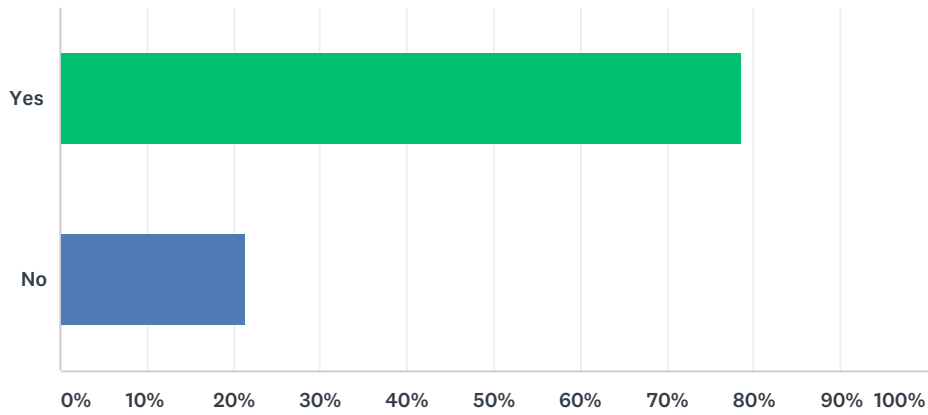

Q4 Do you believe employing a full-time school resource officer at Northwestern would improve the level of safety and security in our schools?

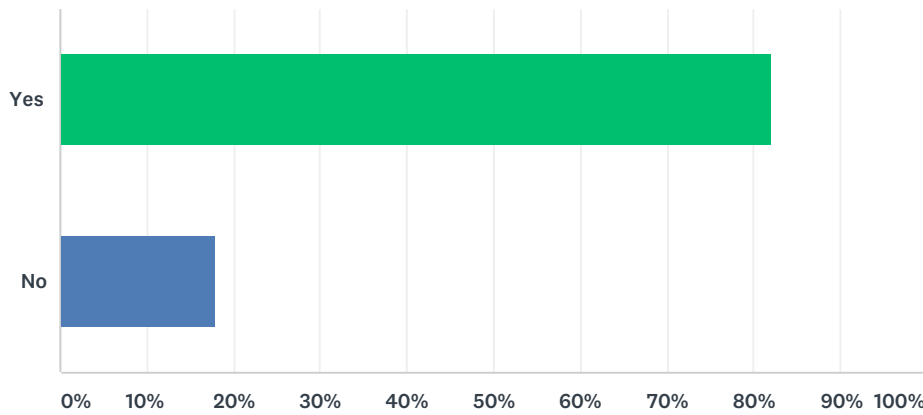

Q5 Would you be in favor of the district employing a school resource officer?

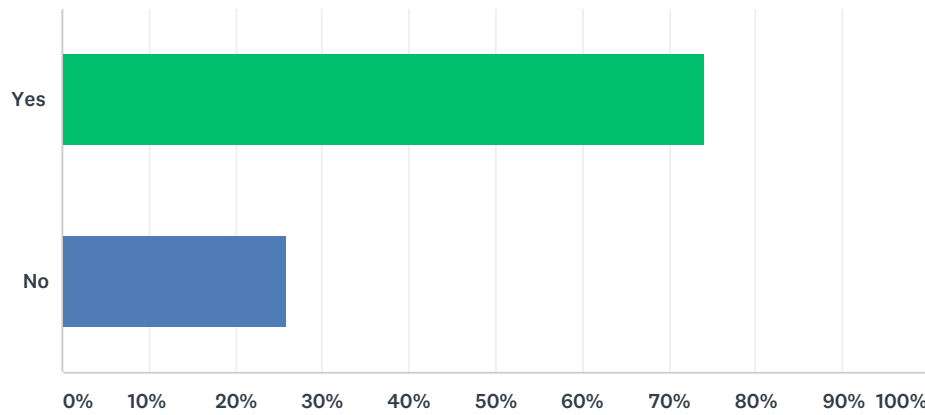

Q6 Would you be willing to support the ongoing cost and training of a resource officer through an additional levy?

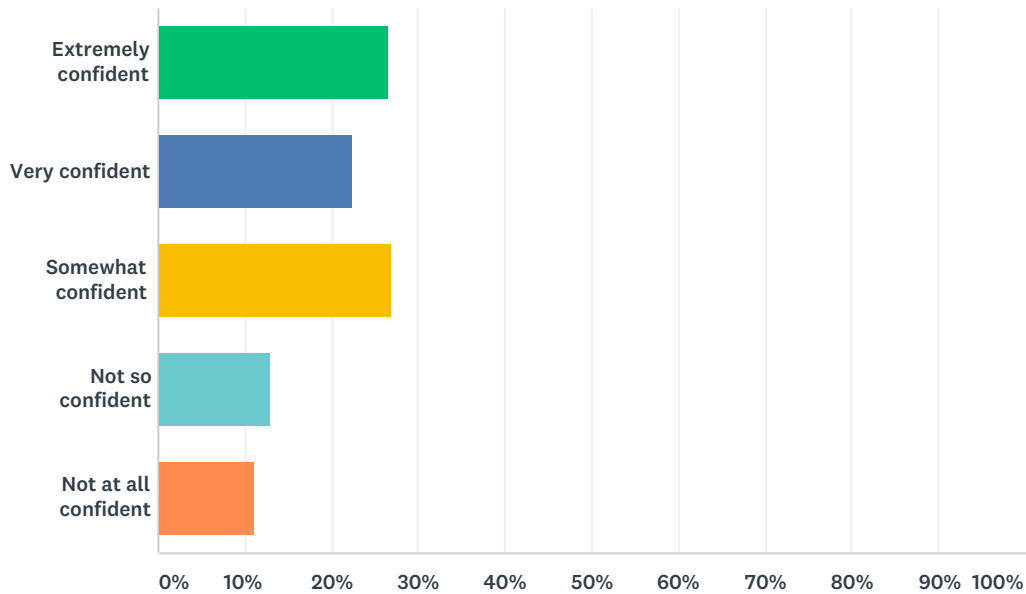

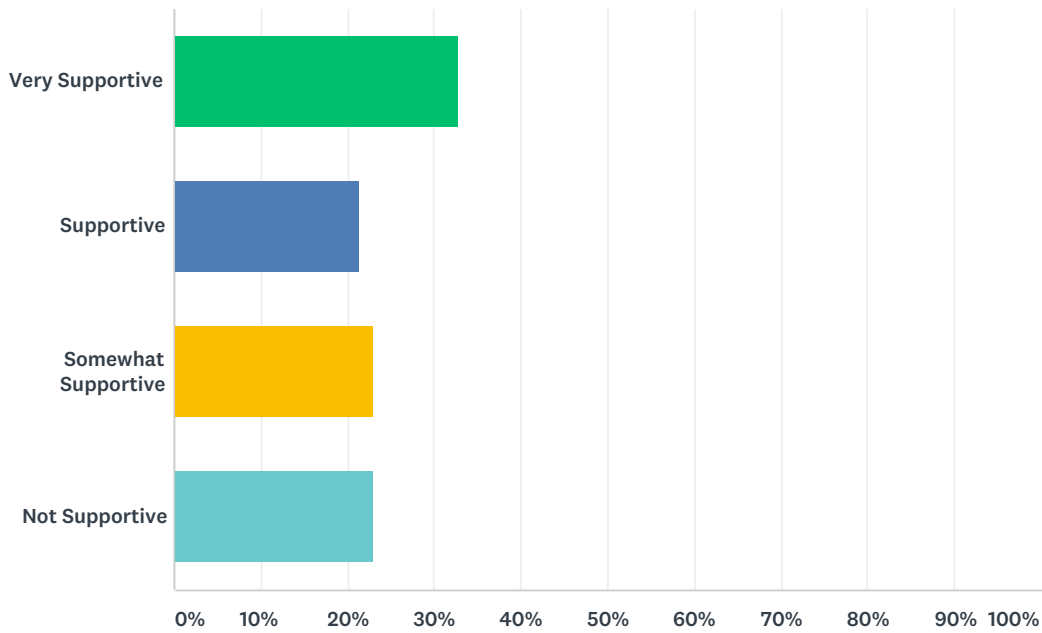

Q8 What is your position on whether select school personnel should be permitted to carry a weapon during the school day?

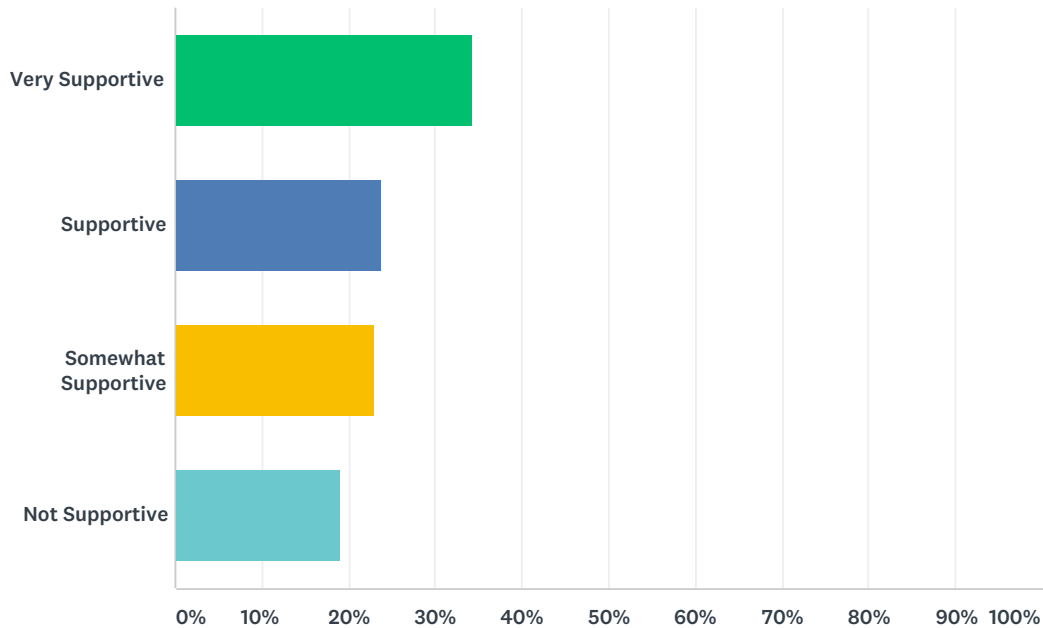
